INTRODUCTION

Waste management legislation is complex and getting it wrong could land your company, and those responsible for any breach, in court. Managing your company's waste properly is not just about covering the legal angles. Waste is gradually becoming more expensive but, with costs spread around the organisation, the total waste and its cost are not always obvious. If you are not looking at waste costs – then what about your competitors? This course identifies the legal obligations of all those handling waste and provides practical solutions for waste management practices and significant cost savings. Companies with ISO 14001 certified systems can demonstrate improved competency in their management of waste and particularly if seeking improvements in this area this course can help to identify potential opportunities. Delegates are required to complete a multi-choice exam paper at the end of the course.
